Short history of Clamper Square.

It's about the size of a substandard city lot. At the intersection of Railroad Avenue and the Sacramento Street off-ramp from the Golden Center Freeway in Nevada City is a piece of surplus land deeded to the city of Nevada City by the California Department of Transportation. Its name honors an organization that has itself honored scores of historical sites, events and people by placing bronze plaques with brief histories of the honorees. The name was proposed by Nevada City Councilman Bob Paine to honor the ancient and honorable order of E Clampus Vitus, Chapter #10, Nevada City; the Clampers. It is called Clamper's Square and it began in 1968, when that group dedicated the first ever monument to the memory of the Nevada County Narrow Gauge Railroad near the site of its Nevada City terminal.

To some, Clampus Vitus, or Clampers, as members are called, may not be familiar; to others, a Clamper conjures up visions of a red-shirted male adult acting like a tipsy college fraternity member; to still others, a Clamper is seen as a guardian of local history, a member of that of inveterate, plaque-placing brotherhood.

The Narrow Gauge monument is of stone with a bronze plaque attached. It was placed and dedicated May 8, 1968, with suitable pomp and ceremony. Taking a central role in the dedication were Johnny Nolan, the railroad's last master mechanic and Bob Paine, the road's last freight and passenger agent. The Clamper chapter's Noble Grand Humbug (president) Dave Durand led the festivities, which included firing of much blank ammunition since no cannon was available to approximate the railroad's first dedication – which took place two weeks shy of 92 years earlier. Let's go back.

At that time, a cannon had been dragged to the top of Sugar Loaf and "boomed forth in noisy hilarity" preceding and during the festivities.

May 20, 1876, dawned cold and rainy in Nevada City. All the previous night, gale force winds accompanied by heavy snow had lashed the western county. The morning still brought small amounts of blowing snow to add to the discomfort of those who gathered for the scheduled ceremony. The Nevada City Brass Band entertained a shivering crowd, huddled under their umbrellas, with a program of old favorites.


Driving of the last spike by county physician Dr. Robert M. Hunt marked the completion of the railroad and was followed by an oration by Judge Niles Searls, one of the original directors of the road, ending with these lines:

"We present you, fellow citizens, the Nevada County Narrow Gauge Railroad as a Centennial gift (1876 was the United States' 100th year). The magnitude of this offering cannot be realized today. We are willing to wait ... (for) the second Centennial ... then shall the munificence of the gift be appreciated and the yet unborn orators of that epoch shall say ... they builded better than they knew."

Unfortunately, Judge Searls' optimism was not borne out by history and the little road lasted a scant 68 years, far short of the predicted "second Centennial." In 1942, the Narrow Gauge became a victim of highway transportation. Shortline railroads had outlived their usefulness as freight and passenger carriers. World War II was raging, and the rails and rolling stock became part of the "war effort."

Back to 1968. The corner was landscaped with three giant sequoias. Each tree was named for a member of the immediate Kidder family: John Kidder, the railroad's builder and longtime president; Sarah Kidder, his wife, who followed at his death as president of the railroad and was the first woman to head a railroad; and their adopted daughter, Sarah's niece Beatrice. The trees were also to replace Nevada City's giant sequoia that was felled in 1965, a scant 100 yards from the memorial, to make way for the freeway. After 36 years, the John Kidder tree is the largest and is followed in size by Sarah and Beatrice. The city of Nevada City maintains the landscaping.

This marker is the first of three placed by the Clampers to memorialize the Nevada County Narrow Gauge Railroad. In Grass Valley, at the corner of Bennett and Kidder streets, is a marker locating the Grass Valley station and headquarters, placed in May 1977. In May 1976, at the old caboose memorial on Main Street, Colfax, is the third marker, jointly sponsored with the Lord Sholto Douglas Chapter #3 of Auburn. It marks the Colfax terminal.
